### ANTI RAGGING MEASURES

Sub:-Formation of Institute level Anti-Ragging Monitoring committee and squads -

First year classes will commence from 1<sup>st</sup> October, 2021. It is our duty to ensure that their stay at IEC-GI will be smooth, enjoyable and free from the menace of ragging.

As per the directions of Hon'ble Supreme Court of India/ University, the Institute has formed the following Anti-ragging committees and squads for supervising the implementation of the provisions of the anti ragging guidelines with immediate effect.

1. The Committee will advise steps and measures to ensure that no/zero ragging incident should takes place within or outside the campus.






2. The brief duties of the various teams are given below:-

(a) **Proctorial Board** will investigate every incident of ragging and will take appropriate actions as per the rules in this regard in consultation with the Director.

(b) **Anti ragging squads (During College Hours)** duty is to visit the class rooms as well as hostels and inform the students of 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> years the consequences of indulging in ragging and counsel the students not to indulge in it. The consequences are very serious if students are caught involved in the act of ragging. Anti ragging squad is to keep tight vigil and take frequent rounds of college and hostel to ensure that no ragging takes place. Immediate action is required to overcome incidents involving ragging. Any such incident is to be immediately reported to the Chairman (Anti Ragging Committee)/Anti Ragging Committee member.



3. All HODs are requested to address the students of their respective departments and counsel them not to indulge in act of ragging. We should seek help of senior students to prevent ragging in college campus.
